General Price List

The Goods and service shown below are those we can provide to our customers. You may choose only the items you desire. However, any funeral arrangements you select will include a charge for our basic services and overhead. If legal or other requirements mean you must buy any items you did not specifically ask for, we will explain the reason in writing on the statement we provide describing the funeral goods and services you selected.

1. BASIC SERVICES OF FUNERAL DIRECTOR AND STAFF.....\$ 2,395.00

Our fee for the service of funeral director and staff includes, but not limited to, staff to respond to initial request for service; arrangement conference with family or responsible party; arrangement of funeral; preparation and filing necessary authorizations and permits; recording vital statistics; preparation and placement of obituary notices; coordination with those providing other portions of the funeral; e.g. cemetery, crematory and others. Also included in these charges are overhead expenses relative to our facility such as insurance, maintenance and utility expenses, secretarial and administrative cost, and equipment and inventory costs.

This fee for our basic services and overhead will be added to the total cost of the funeral arrangement you select. (This fee is already included in our charges for direct cremations, immediate burial, and forwarding and receiving remains.)

2. EMBALMING.....\$550.00

Except in certain special cases, embalming is not required by law. Embalming may be necessary, however, if you select certain funeral arrangements, such as a funeral with viewing. If you do not want embalming, you usually have the right to choose an arrangement that does not require you to pay for it, such as a direct cremation of immediate burial.

Our services include set-up of visitation area, placement of encased remains, display of floral arrangements, supervision of and attendance during the visitation. (Charge per day.)

11. FORWARDING REMAINS TO ANOTHER FUNERAL HOME.....\$2,495.00
 This charge includes removal of remains, necessary services of funeral director and staff, necessary authorizations, embalming, and local transportation to airport. This fee includes a minimum shipping container.

12. RECEIVING REMAINS FROM ANOTHER FUNERAL HOME.....\$2,495.00
 This charge includes temporary shelter of remains, transportation of remains to local cemetery or crematory, and necessary service of funeral director and staff.

13. IMMEDIATE BURIAL.....\$ 2,950.00
 Our charge for an immediate burial, without any attendant rites or ceremonies, includes local removal, refrigeration, disinfecting, dressing and casketing body, local transportation to the cemetery, necessary services of funeral director and staff. This fee does not include any casket, alternative container, or outer burial container costs. You may provide your own casket or container, or purchase one from the funeral home's casket price list.

14. DIRECT CREMATIONS.....\$2,340.00 to \$2,395.00
 If you want to arrange a direct cremation, you can use an alternative container. Alternative containers encase the body and can be made of materials like fiberboard or composition materials (with or without an outside covering). The container we provide are fiberboard cremation containers. Cremation options on reverse side. See page two.

15. BODY DONATION TO UVM.....\$1,595.00
 Our charge for donation to UVM, Burlington, VT, without any attendant rites or ceremonies includes local removal of remains, transportation to Burlington, authorizations and necessary services of funeral director and staff.

16. Our basic service charge includes a \$ 6.00 that will be sent to the State of Vermont and set aside for the protection of funeral service customers.

17. Funds may be available for final disposition through the Vermont Department of Social Welfare, General Assistance Program, for persons who qualify. See funeral director for details.

- * Refrigeration period.
- * Minimum cremation container as required by the crematory.
- * VT Medical Examiner's Permit for cremation.
- * Transportation to the crematory and retrieval of cremains.

This fee does not include any casket, alternative container. You may provide your own casket, container, or shroud, or purchase one from the funeral home's casket price list.
